ORDER

The Director, Asian School of Business as per the letter read as 1st above has submitted application for NOC for the conversion of Post Graduate Diploma in Management (PGDM) course into Master of Business Administration (MBA) course.

The Director of Technical Education as per the letter read as 2nd above has recommended that the request of the Director, Asian School of Business may be considered.

Government have examined the matter in detail. As per the IIM Act which came into force on January 31, 2018 the two year PGDM courses will be converted to MBA degrees from the 2019-20 session. In this circumstance, Government are pleased to grant NOC to Asian School of Business, Technocity, Pallippuram, Thiruvananthapuram for conversion of PGDM course into MBA course during the Academic year 2019-20 subject to the following conditions mentioned in the Undertaking and Resolution furnished by the Educational Agency and subject to the affiliation of the CUSAT, Cochin:-

- i) Students who are undergoing studies/students who are trailing due to failures in the courses (if any) shall be permitted to complete their studies in the College itself at the prevailing fees.

ii) Liabilities (if any) of the institution due to the above said courses shall be at the sole responsibility of the Trust and shall be settled as per the rules and regulations as applicable.

iii) The conversion of the course will be subject to the conditions mentioned in the Undertaking and Resolution submitted by the institution and also any legal issue in this regard must be at the sole responsibility of the management.
